#### Overview

This course focuses on the main features of contemporary political systems in Europe, with special emphasis on Western Europe. The course provides an introduction to European electoral and party politics, political behaviour, and the theoretical foundations of different types of government. Case studies will be used to highlight the functioning of different political systems across the continent such as the United Kingdom, the Netherlands, Scandinavia, Southern Europe and France.

Students are not expected to read everything on this list. However, they are are expected to read at least one of the required readings for each topic and contribute, accordingly, to the class discussion and/or group activity that will take place at the end of each session (last hour). The reading list is not exhaustive, but provides the basis from which students can pursue further independent reading. Please contact me if you encounter any problems in accessing the required or additional readings.

# **Objectives**

By the end of the course, students should be able to:

- Understand of the historical foundations of current issues in European politics
- Identify the main differences across political systems and its consequences for democratic functioning
- Ability to apply theoretical approaches to political 'practice'
- Critical understanding of the literature
- Develop skills to conduct research and produce written scholarly material

# Assessment & Key dates

- Participation 10%: students are expected to read the compulsory readings weekly and to contribute actively to class discussions / exercises.
- Midterm exam 25%, (Oct 19th). Guidance / practical examples will be provided prior to the exam date.

The *midterm* and *final* exams will consist of multiple choice questions and short answer questions. The exams will cover the course material, including assigned readings, lectures, and classroom discussions. A make-up exam will be administered only in case of a medical emergency.

• Research paper 25% (Nov 9th): titles will be made available by the course supervisor. Research papers should be 3000 words long (10% above/below tolerance policy). Students are allowed to choose their own topic according to their research interests - prior discussion with the course supervisor.

The paper handed in after the last class will be considered late. The late assignment will receive a ten percent penalty per each day of lateness.
